




Plan de Implementación (PdI) de Medidas y Acciones REDD+ en Territorios Indígenas Amazónicos del Ecuador

- Sumaklia sacha aychakunata kuyrankawa kay nacionalidad Shiwiar NASHIE (PASUNK)
